

SEVENOAKS ANNUAL PRECEPT £1,545,147

• 77% of the budget comes from the domestic ratepayer's precept (council tax). The Town Council does not receive any portion of business rates or government grants.

RTW TOWN COUNCIL PRECEPT £2,560,075

• TWBC Council Tax (larger due to RTW's relative size) Already collected as part of TWBC Council Tax as Special Services.

SEVENOAKS INCOME FROM SERVICES £451,949

• 22% of the budget comes from fees and services such as community halls, sports pitches, markets, cemetery, and cafe.

RTW INCOME FROM SERVICES £258,925 plus?

- Depends on assets and services retained by RTW Town Council.
- Assumes limited services retained as per TWBC budget). Could be substantially expanded based on assets and services within RTW and/or owned prior to TWBC.

RTW - Potential

There are comparable services and assets held in RTW which COULD be retained by the Town Council. Examples of note:

- Our Cemetery is a larger income producer
- Our multi story car parks are more significant.
- The **Town Hall** is a substantial asset currently over half used to generate income from shared working space.
- RVP is on land originally owned by Tunbridge Wells (predating TWBC)
- The Canden Centre, TN2, The Pump Room, The Amelia, The Assembly Hall provide Community spaces
- The St John's sports centre is leased by TWBC to the existing operator, earning money for both
- Several buildings (shops, homes and facilities) are owned by TWBC earning rental income
- Each service and asset needs to be reviewed

- I. Annual Income from Services £258,925 (based on limited services retained)
- II. Annual Town Council Tax £2,560,075

Annual Cost per Household (Band D) £134.79 per year / £2.59 per week



RTW Town Council - Challenges and opportunities

Challenges and Strategic Goals for RTW Town Council will need to be developed amid the challenge of the formation of West Kent Unitary Authority. Their focus will be on the difficult financial challenges of providing obligatory services and the funding of the sizeable debts inherited.

Some initial potential issues and goals:

- 1. TWBC does not have debt but does own substantial assets in RTW.
- 2. The Town Council's priorities will be ensuring existing services in RTW continue to operate cost effectively. Sevenoaks makes substantial use of the Volunteer Sector. We should do likewise, reinforcing the invaluable work of existing local voluntary groups by enhancing funding opportunities.
- 3. We need to address town specific issues inherent in our town with its long linear form and steep hill to unite activities to benefits our residents, preferably on a self funded basis.
- 4. We should support "free to attend" community events such as Local & Live, The Mela, Lantern Parade and paid for events which also generate income and community.
- 5. Reviewing and consulting on the future of Community Assets subject to the local Government re-organisation.
