

## **FATE OF A TUNBRIDGE WELLS PARK IS BEING DECIDED THIS WEEK**

A planning inquiry is under way to decide the future of Dunorlan Park, in Tunbridge Wells.

Senior Sunrise Living wants to build a giant retirement complex on the park but its first two applications were turned down by Tunbridge Wells Borough Council.

A third application was submitted in December 2007 but council officers did not make a decision in the designated eight-week time period.

So the firm appealed to the Government's Planning Inspectorate - which is now holding a public inquiry on the fate of the park in a packed council chamber at the Town Hall until Friday. A final decision will be made by the planning inspector Terry Phillimore in six weeks time.

If it is given the go-ahead, it would see the demolition of the four homes overlooking the park and the construction of a 99-room building, 43 of which will be specifically for Alzheimer sufferers. Dunorlan Lodge will be retained as a separate residential property within the application site, with the new building separated into five linked elements to "reduce the mass further".
